**PITTSBURGH, PA, July 11, 2019** – The Board of Directors of Arconic (NYSE: ARNC) today declared (a) a dividend of 2 cents per share on the outstanding Common Stock of the Company, payable on August 25, 2019, to the holders of record of the Common Stock at the close of business on August 2, 2019; and (b) a dividend of 93.75 cents per share on Arconic's \$3.75 Cumulative Preferred Stock ("Class A Stock"), payable on October 1, 2019, to the holders of record of the Class A Stock at the close of business on September 13, 2019.
