CONFLICT MINERALS

Arconic-Köfém Mill Products Hungary Kft. ("Arconic-Köfém") hereby declares that it complies with all applicable regulations regarding responsible sourcing of minerals, including those aimed at preventing the financing of armed conflict and human rights abuses through mineral trade.

Our compliance is aligned with:

European Union Regulation (EU) 2017/821 of the European Parliament and of the Council of 17 May 2017, which lays down supply chain due diligence obligations for Union importers of tin, tantalum, tungsten, and gold originating from conflict-affected and high-risk areas. This regulation came into full effect on **1 January 2021** and requires adherence to the OECD Due Diligence Guidance for Responsible Supply Chains from Conflict-Affected and High-Risk Areas.

United States Dodd-Frank Wall Street Reform and Consumer Protection Act, Section 1502, which mandates publicly listed companies to disclose annually to the U.S. Securities and Exchange Commission (SEC) whether their products contain tin, tantalum, tungsten, or gold sourced from the Democratic Republic of the Congo or adjoining countries, and to report on due diligence measures taken.

Arconic-Köfém does not file reports to the SEC and have no legislative obligation to comply with the conflict minerals requirements of the Dodd-Frank Act.

However, we acknowledge the importance of the issue and engages in ongoing and close dialogue with its suppliers about sustainable business practices and transparency of material use.

To support these obligations and ensure transparency across our supply chain, we utilize standardized reporting templates developed by the **Responsible Minerals Initiative (RMI)**:

- **Conflict Minerals Reporting Template (CMRT)** – The CMRT is used to collect refiner and processor information to fulfill regulatory 3TG reporting requirements.
- **Extended Minerals Reporting Template (EMRT)** – The EMRT is a voluntary initiative that allows downstream companies to disclose their cobalt and mica sourcing due diligence efforts in their annual reports and/or on their website. Rather than a requirement, it currently serves as an aid to due diligence and identifying utilized smelters and refiners of cobalt and mica. does Arconic not maintain a reporting template on cobalt and mica since there is no current requirement to report on usage or sourcing by our supply chain, as cobalt and mica are not considered conflict minerals within the scope of U.S. regulation.
- **Additional Minerals Reporting Template (AMRT)** – The AMRT is a voluntary initiative that allows downstream companies to disclose supply chain data for any prioritized minerals that are not covered by the CMRT or EMRT. The scope of the AMRT is determined by the user. As there is no current requirement to report on minerals other than 3TG, Arconic does not maintain a reporting template for extended or additional minerals.

Our company issues, collects, and reviews these templates from suppliers as part of our annual reporting process. We maintain documented evidence of due diligence, smelter/refiner identification, and country-of-origin inquiries to ensure responsible sourcing practices.
